FINDINGS, CONCLUSIONS, AND RECOMMENDATIONS

Our compliance audit report contains one finding concerning a procedural matter. The Authority's uncollectible receivables were not referred to the Comptroller's Offset System for possible collection. Also, certain types of uncollectible receivables were written-off without first being certified as uncollectible by the Attorney General. Though the Authority actively pursues amounts due them, they agreed to take these additional required steps prior to writing-off future uncollectible receivables.

Our auditors state that the June 30, 1993 financial statements of the Illinois Farm Development Authority are fairly presented.
