INTRODUCTION

The State Universities Civil Service System (System) is under the direction of the University Civil Service Merit Board. The System works to establish a sound program of personnel administration at State-supported institutions of higher education and at certain allied agencies. The System provides direct guidance and support services in such areas as employment, examinations, classification plan management, salary administration, compliance audit reviews, disciplinary procedures, and other business operations related to the management of support staff personnel.

There were no material findings of noncompliance disclosed during our examination.

We conducted a compliance examination of the System for the two years ended June 30, 2017, as required by the Illinois State Auditing Act. The accountants stated the System complied, in all material respects, with the requirements described in the report.
