RE: Notice of Intent to Issue Requests for Proposals, Revised

On November 1, 2022 the Office of the Auditor General (Office) issued a Notice of Intent to Issue Requests for Proposals from qualified firms of certified public accountants to conduct numerous financial audits and compliance attestation engagements. At that time, the Office provided on its website at https://auditor.illinois.gov/Procurement-Bulletin/RFPs/Opps-Intent.asp a list of agencies for which Requests for Proposals would be issued. The Request for Proposals were separated into four separate groups.

At this time, the Office plans to remove the Executive Ethics Commission (RFP 23-16) Request for Proposal from Group 4 and add it to a newly created Group 5. In addition, the Office plans to add an additional four engagements to Group 5. These four additional engagements include the Deaf and Hard of Hearing Commission, Illinois Independent Tax Tribunal, Illinois Council on Developmental Disabilities and Illinois Board of Higher Education. Group 5 Request for Proposals will be issued May 9, 2023 with proposals due on May 23, 2023 and an expected award date of June 23, 2023. The Office's Procurement Bulletin is on our website as listed above. The OAG Procurement Bulletin contains information about the upcoming audit engagement(s) for which we will be issuing a Request for Proposals, as well as about our prequalification process. The full text of these RFP's will be available on our website on the day of issuance.
