On November 1, 2023 the Office of the Auditor General (Office) issued a Notice of Intent to Issue Requests for Proposals from qualified firms of certified public accountants to conduct numerous financial audits and compliance attestation engagements. The Request for Proposals were separated into four separate groups.

At this time, the Office plans to remove the Prisoner Review Board (RFP 24-12) Request for Proposal from Group 4. In addition, the Office plans to add the Illinois State Police engagement to Group 4 as RFP 24-14. The dates denoted in the November 1 Notice of Intent still apply to the Group 4 Request for Proposals. The Office's Procurement Bulletin is on our website as listed above. The OAG Procurement Bulletin contains information about the upcoming audit engagement for which we will be issuing a Request for Proposals, as well as about our prequalification process.
